Submission of Abstracts - Author guidelines

Abstract should report original research in any area of Biochemistry or Molecular Biology that has not been published or presented elsewhere. The complete abstract should be submitted in electronic format only, to the following email address; collegeofbiochemistssl@gmail.com, with Abstract submission in the subject line.

All correspondence regarding the abstract will be with the author who submits the abstract (Corresponding author should be submission author).

Membership of the college is not a requirement for submission of abstracts and presentation at the conference. All abstracts submitted according to the following guidelines will be peer evaluated prior to acceptance. Authors may be asked to make amendments to the abstract based on peer review. CBSL reserves the right to edit the abstract prior to publishing. All presenting authors should register for the conference following acceptance of the abstract by the given deadline.

Format:

The entire contents of the abstract (including the title and authors) should fit within one A4 page with 2.64 cm(l inch) margins all around. No header or footer.

Line spacing 1.5 (18 pt).

Abstract title and author information should be center-justified. The main body of the abstract should bejustified.

Typeface: Text; Times New Roman 12 point throughout.

Abstract No. The first line of the page should carry the words "Abstract No." and be right-justified.(Number will be assigned by CBSL)

Title: In bold type, centered on the page, maximum 20 words. Capitalize the first word and proper nouns only. Avoid the use of abbreviations.

Authors: Initials and surnames should be given. There should be no full stops between initials in the name. Names should be separated by commas. Presenting author¹ (underlined).

*Corresponding author² (asterisk)

Affiliations: Italicized. If there is more than one affiliation, should be related by superscript numbers after the name. The Author's affiliation¹, Author's affiliation². Authors with the same affiliation should carry the same superscript. If all authors have the same affiliation, no superscript number is required. The corresponding author's-e mail address is to be included in the next line.

Abstract body: Maximum 300 words. Should begin after leaving a blank line after author affiliations. Should comprise a background, objectives, methods, results, and conclusion (with the respective headings) All units should be as SI units. No tables, figures, or references.

Acknowledgements: (if any) should be limited to sources of funding. Eg: Financial assistance by Research grant (number).

Ethical clearance: It is mandatory to submit the letter of approval by an Ethics Review Committee for all studies conducted on Humans and animals.

Format of the document: The entire contents to fit onto a single A4 page size; Margins 2.54 cm (1 inch) all round. Line spacing 1.5 (18 pt). Font Times New Roman, 12 point. Acknowledgments: Financial assistance by.... Grant (no).
